In the context of Nigeria, where remote and underserved areas face significant challenges in establishing traditional educational infrastructure, ODL emerges as a viable alternative (Okoli, 2018).

Moreover, the flexibility offered by ODL aligns with the diverse needs of learners in these areas. The ability to access educational resources and engage in learning activities at one's own pace is critical, particularly in regions where agricultural or livelihood commitments may hinder regular attendance in traditional classrooms (Garrison & Kanuka, 2004).

Open and Distance Learning (ODL) leverages digital platforms to eliminate the barriers posed by geographical distance (Kulal, Dinesh, Abhishek & Ancha, 2024). This is especially pertinent in Nigeria's remote areas where the establishment of physical educational infrastructure is often economically and logistically challenging.

The flexibility inherent in ODL addresses the unique challenges faced by learners in remote areas, allowing them to balance educational pursuits with familial and work obligations (Nazife, 2023). Asynchronous learning, in particular, enables individuals to engage with course materials and assessments at times convenient for them.

ODL reduces dependence on extensive physical infrastructure, making education more accessible and cost-effective. This is crucial in remote areas where the establishment and maintenance of traditional classrooms may be impractical. Online learning platforms create an environment where gender stereotypes are challenged (Idrizi, Filiposka & Trajkovikj, 2023). ODL promotes inclusivity, offering an equal educational playing field for both men and women, thereby contributing to the dismantling of entrenched gender norms. By minimizing travel expenses and infrastructure requirements, ODL provides a cost-effective solution for both learners and educational institutions, thereby increasing the accessibility of education in resource-constrained areas.

ODL's flexibility is a powerful tool for promoting gender equality, especially in regions where traditional gender roles may limit women's participation in formal education. Women in rural areas can overcome societal expectations and balance their educational pursuits with domestic responsibilities.

For women and girls facing security concerns, ODL provides a safe and secure learning environment.

Cultural considerations are paramount in ODeL implementation. As noted by Anderson and Dron (2011), understanding cultural nuances is crucial for effective online pedagogy. The adaptation of ODeL to local contexts is essential to ensure relevance and resonance within the diverse cultural landscape of Nigeria.

Challenges in implementing ODeL are recognized by Krishna (2022), who emphasizes the need for robust infrastructural support. Issues of technological access, connectivity, and digital literacy must be addressed to maximize the benefits of ODeL, particularly in regions facing socioeconomic disparities.

Gender dynamics play a significant role in education. The work of Kuteesa, Akpuokwe and Ude (2024) underscores the importance of ODeL in addressing gender disparities, offering flexibility that can empower women to engage in education without compromising familial or societal roles.

Disparities in Access to Open Distance and e-Learning (ODeL) Among Different Socioeconomic Groups

Lower socioeconomic status individuals may face financial constraints in accessing online education, as initial investment in technology, internet subscriptions, and software may be prohibitive. (UNESCO, 2020) emphasizes the need for financial support and inclusive policies to ensure that cost does not become a barrier to ODeL access, particularly for marginalized socioeconomic groups.

Government policies, such as subsidies for digital devices and internet connectivity, and improvements in technological infrastructure in underserved areas, are crucial in reducing ODeL access disparities. The National Policy on Education in Nigeria (Federal Republic of Nigeria, 2014) emphasizes the need for inclusive educational practices, aiming to address disparities and promote equal access to quality education. However, effective implementation remains a challenge.

For instance, the Malaysian government implemented the My Digital initiative, which includes financial aid schemes to support students in acquiring the necessary digital tools for online

learning (Ministry of Finance Malaysia, 2021). Governments must invest in infrastructure development to make ODeL accessible to all, including expanding broadband connectivity in rural and underserved areas for diverse online education participation. In India, the Digital India initiative has been instrumental in expanding digital infrastructure, thereby enhancing the accessibility of ODeL across the country (Sindakis & Showkat, 2024).

Government policies should prioritize quality assurance mechanisms for ODeL programs, including accreditation processes, teacher training programs, and monitoring systems to maintain high educational standards. The Quality Matters program in the United States serves as an example of a quality assurance initiative that sets standards for the design of online and blended courses (Quality Matters, n.d.).

Government policies should prioritize the needs of marginalized groups, including disabled individuals, ethnic minorities, and remote areas, by implementing inclusive education policies that provide targeted support and resources. The National Policy on Education in Nigeria explicitly emphasizes the promotion of inclusive education and addressing the needs of diverse learners (Federal Republic of Nigeria, 2014).
